

PARENTAL RELEASE FORM-LITTLE LEOPARD CHEERLEADING CAMP

The undersigned, being at least eighteen years of age, and the custodial parent or guardian of a participant of the Cheerleading camp and in consideration for the right to have my child in the Cheerleading Camp, offered at East High School in the Salt Lake City School District do hereby agree to this release and waiver.

In consideration for participation in this course, my child agrees to abide by and follow all safety rules and procedures for the camp, and have discussed them with my child. I understand that violation of these rules of procedures can result in my child not being allowed to participate in a particular activity or it may result in he or she being excluded from the camp.

I recognize that the camp activities will involve physical activity and may cause physical/emotional discomfort. I state that my child is free from any known heart, or other serious health problems that could prevent my child from participating in any of the activities associated with this camp. I further state that my child is sufficiently physically fit to participate in the activities of this camp as described in the camp description or syllabus. I understand that instruction will be given on the various activities before my child is allowed to participate in them and that the camp instructor or another adult will provide general supervision to my child and to the camp in general, but he or she will not be under constant direct adult supervision.

I recognize that in order to successfully complete this camp, my child will be required to participate in the activities described in the attached course description. I recognize that Cheerleading Camp is a potentially hazardous activity carrying a risk of personal injury. I further recognize that there is a natural and manmade obstacles, hazardous surfaces, and other conditions and risks which in combination with my actions or the actions of others, can cause severe or fatal injury. I hereby fully agree to assume all risks which may be associated with or result from my child participating in the aforementioned activities or the activities described on the attached camp description.

I further agree to release the Salt Lake City School District, its agencies, officers, employees, instructor, administrators, agents, (entity or persons) and all sponsors and/or officials, and staff of any said entity or person, their representatives, agents, affiliates, directors, servants, volunteers, and employees from any and all liability, claims, demands, actions, and causes of actions whatsoever for any loss, claim, damage, injury, illness, or harm of any kind or nature arising out of my child's participation in this camp.

I further agree to hold harmless and hereby release the above mentioned entities and persons from all liability, negligence or breach of warranty, and attorney fees associated with injuries or damages and from any claim by me, my family, estate, heirs or assigns arising or in any way connected with the aforementioned activities.

CONSENT

Consent is expressly given in the event of injury, for any emergency medical aid, anesthesia and/or operation, in the opinion of the attending physician, if such treatment is necessary.

I HAVE CAREFULLY READ AND UNDERSTAND THE CONTENTS OF THE FOREGOING LANGUAGE AND I SPECIFICALLY INTEND IT TO COVER MY CHILDS PARTICIPATION IN CHEERLEADING CAMP FROM September 21st to September 25th 2009.
